Renewal Notice for all Business Licenses & Occupational Tax Certificates (Renewal application and payment of fees are due by 11:59 pm on December 31st of each year. If renewal application and payment of fees are not paid in full by 11:59 pm on February 15 of each year, a late fee will be applied (this grace period does not apply to Beer & Wine License Renewals, these licenses must be renewed by December 31st). At 12:00 am on March 1, a business license renewal will not be processed. If a business license renewal has not been completed prior to 12:00 am on March 1st, the business license will be revoked, and the business owner will be issued a citation for operating a business without a license.):

Please follow the necessary steps, listed below, to renew a Troup County Business License & Occupational Tax Certificate:

- Submit a completed Troup County "Business License & Occupational Tax Certificate Renewal Form".
- Submit an "Affidavit Verifying Status" certifying legal presence in the United States.
- Submit a copy of a "Secure & Verifiable Document" to prove legal presence in the United States. A Driver's License or a U.S. Passport / Naturalization Document, if you are a U.S. Citizen. If you are a Permanent Resident, you must submit a copy of your Permanent Resident Card (copy front and back). If you are a qualified alien, you must submit either a valid foreign passport with your I-94, a Temporary Resident Alien Card (I-688), an Employment Authorization Card (I-766 or I-688B).

- Submit an "E-Verify Affidavit". All private employers with more than 10 employees as of July 1, 2013, are required to register with the Federal work authorization program, also known as E-Verify.
- Please visit <a href="http://www.uscis.gov/">http://www.uscis.gov/</a> for E-Verify registration instructions.
- Submit a "<u>Fee Schedule</u>" including the total number of full time employees and the annual fee payment made payable to **Troup County**.
- Submit a copy of your annual business registration with the Georgia Secretary of State office (can be obtained at <a href="https://sos.ga.gov">https://sos.ga.gov</a>).
- Submit an updated copy of your State of Georgia Professional / Trade License.
- Proof of yearly inspection by Troup County Fire Marshal (Personal Care Home, Group Homes, Home Day Care, Commercial Day Care, Food Trucks).
- Troup Health Department Certificate (restaurants, food trucks).
- Department of Agriculture updated Cottage Food License and animal related certificate.
- Georgia Tax Center Retail Beer & Wine / Pouring Certificate (updated).
- Submit an updated copy of your ServSafe / Food Handler's certification, where applicable (Cottage Food, Caterers & Restaurants, Food Trucks and all Food Services)
