Regular meetings held on the first Tuesday will begin at 9:00 a.m. and regular meetings held on the third Tuesday will begin at 5:00 p.m.

- All meetings other than regular meetings ("Called" meetings) shall be announced through posting in the Troup County Government Center at 100 Ridley Avenue at least 24 hours in advance of the meeting at the place of regular meeting and written or oral notice of all such meetings shall be given at least 24 hours in advance to the county legal organ and/or a paper that has the equivalent circulation.
- Emergency meetings may be held upon the provision of reasonable notice under the circumstances, to include (1) notice to the county legal organ or its equivalent, (2) recording in the minutes the need for the emergency meeting, and (3) providing telephonic, facsimile or e-mail notification to other media outlets that have a place of business in the County that have requested such notice.
- All members of the public who wish to address a specific topic not on the board agenda must submit their name and topic to the Commissioners' Office (County Manager) at least three business days before the board meeting.
- By concurrence of a majority of the members present, the Board may allow public comment on items, which are on the agenda.

In addition to the above regularly scheduled and called meetings, the Board also conducts an informational work session each Thursday
which precedes a regularly scheduled Tuesday meeting. Work sessions are held in the Commission Chambers on the first floor of the Troup
County Government Center at 100 Ridley Avenue. The work session preceding the first meeting of the month will begin at 9:00 a.m. and the
work session preceding the second meeting of the month will begin at 5:00 p.m. and are open to the public. While the work sessions are
generally informational only, if circumstances require it, votes may be taken.
